DISCOUNT POLICY – 1 July 2023

The fees due to a notary in the exercise of their activity are subject to a rate that is set by decree. The amount of these fees is thus identical regardless of the client, the notary or the geographical area.

.

The rate is either set or proportional to the capital expressed in the deed.

When the notary acts as an adviser, or as drafter of a deed not subject to the rate, they are then remunerated by fees, subject to an agreement freely negotiated with their client.

Law No. 2015-990 of 6 August 2015, Decree No. 2016-230 of 26 February 2016, the Decree of 26 February 2016 and the Decree of 28 February 2020 set the regulated rates for notaries.

Since 1 January 2021, a notary can grant their clients a discount on their fees, capped at 20%, beyond a certain range of bases. This discount may be up to 40% for certain acts exhaustively listed and relating to goods or rights with a value of more than €10,000,000.
